# About this project

The PREV-HED project promotes the interconnection of higher education institutions by working with university professionals and exchanging good practices between universities. The project aims to create a positive dynamic for the prevention of sexual harassment throughout the European university system by proposing effective prevention strategies adapted to the specificities of European universities. Moreover, the project encourages universities to work together to promote innovative and effective practices for the prevention of sexual harassment.

The PREV-HED project aims to create a respectful and inclusive university culture for all by building the skills of university professionals, promoting innovative sexual harassment prevention practices, and encouraging the civic engagement of university staff. The PREV-HED project builds on the experience of European universities that have already implemented sexual harassment prevention policies and worked on innovative practices to promote a respectful and inclusive university environment for all. By exchanging good practices between universities, the PREV-HED project aims to create a positive dynamic for the prevention of sexual harassment throughout the European university system.

# Target groups

The direct target groups that will participate in the project implementation are **the teachers and administrative staff** from each HEI that will take part in the piloting activities; **The students' associations** that will be impacted by dissemination activities and invited to also participate in the internal pilot; **the students** in general.

**The indirect target groups** are **the university professors, teachers and administrative staff** not directly participating on the project, **researchers, universities not participating in the project directly, VET institutions, adult education institutions, NGOs** providing non-formal education to young people, **all teachers and trainers from VET**, adult and non-formal education.

Stakeholders of PREV-HED project interested in disseminating the project outcomes and outputs are **public authorities with competences in education, European Policy makers, associated partners.**

# Objectives



## ✓ General objectives:

The PREV-HED project aims to fight against sexual harassment in European universities by working specifically on the prevention of this phenomenon; to strengthen the skills of all university professionals (teachers, administrative staff, researchers, etc.) to deal with this scourge. It also proposes to raise students' awareness of respectful behavior and to prevent sexist and sexual violence.

The project also plans to put in place reporting and support mechanisms for victims.

## ✓ Specific objectives:

The implementation of effective prevention policies adapted to the specificities of European universities aims to promote innovative practices of sexual harassment prevention throughout the European university system.

The project seeks to contribute to the creation of safe, inclusive and respectful university environments for all, as well as to the promotion of gender equality and the protection of the fundamental rights of students and teachers.

# Project results:

**R1-** A report on best practices and effective supporting system for victims of SRGBV.

**R2-** A training course for staff from HEI on prevention and action protocols.

**R3-** Creation of a chatbot for early advice for students.

**R4-** Pilots inside each HEI that include the creation of contact points inside each institution.
